HOW YOUR EXPERIENCE WILL BE

Participants are grouped into different teams. In an initial briefing, the judge-referees of Exploramás explain the particulars of this sport and the competition system established.




The teams face each other in a classification system that includes prior rounds, an elimination phase and the grand final, depending on the size of the group of participants.

Teams can be made up of two, three, four, five or six players, depending on the size of the group.

The rules of the competition are those of Beach Volleyball, each match being the best of three sets played between two teams. The match ends when one of the two teams wins two sets. The first two sets are played to 21 points, while the last, if necessary, is played to 15.

Scoring, however, can be adjusted and adapted to the physical level of the participants.

CONTRACT CONDITIONS

General Contract Conditions

Activities

EXPLORAMAS is a company that specialises in event-organization and tourist activities which can be found in the Andalusian Tourism Registry (TA/MA 00004). Exploramás takes care to comply with all requirements for companies that run activities outdoors.

All Exploramás activities are respectful of the environment, and all that it gives to us as a society, which is why we have the utmost respect for the fauna, flora and the entirety of the natural landscape.

For all Exploramás activities, we have a trained specialists with specific knowledge of the program area. These specialists will be in charge of ensuring compliance with all environmental norms as well as safety during the activities. They will carry out any emergency or evacuation plans if necessary. They will check that all equipment used during the activities are in good condition and they will prevent those with specific ailments or injuries from participating in activities that might be hazardous for them.

PAYMENT TERMS

I.- Booking:

To finalise a reservation to do an activity with us, you must deposit 50% of the quoted price at the following Solbank account:

The deposit must be made when you receive the Pro Forma Invoice. The remaining balance must be payed 14 days before the activity begins. Failure to pay in said period will cause the following stipulation to go into effect:

II.- Total Cancellation:

The services that have been contracted can be annulled, with the payment being owed to the organisation for the costs undertaken to organise the activity, if any such costs exist, as well as cancellation costs for the following amounts.

- 50% of the total price is the cancellation happens more than 10 days but fewer than 15 days before the agreed upon date to start the activity.
- 75% of the total price is the cancellation happens more than 2 days but fewer than 10 days before the agreed upon date to start the activity.
- 100% of the total price is the cancellation happens more than within 48 hours before the agreed upon date to start the activity.

The cancellation request must be sent to Exploramás by fax, e-mail, or mailed to the address contained in this document and the cancelling party must maintain a copy of the document as proof of the date and time of the cancellation request. Without a copy of the sent document, the cancellation request will not be accepted.

III.- Partial cancellation:

The deadline for responding to client requests for variations in the number of participants is 4 days before the activity is due to take place.

In the event that there is an increase or decrease in the number of participants, the budget accepted by the client will be valid for a variation of participants of up to 20%, Exploramás reserving the right to make a new budget for the indicated case.

GENERAL CONDITIONS

1.- Exploramás maintains an insurance plan for civil liability that adequately covers any potential responsibility that can be attributed to the company for risks stemming from the activities which applies to participants and third-parties. Also, the activities include an obligatory insurance in case of accidents with the following coverage options:

Obligatory Insurance for Accidents:

Death 10.000 €

Disability 10.000 €

Medical Assistance: 6000 €

Insurance for death for children under 14 years old is not included. Insurance for disability for participants over 70 years old is not included.

2.- The activities are dependent on weather conditions as well as the personal condition of the participants or any unforeseen circumstances that might affect the participants. The dates, itineraries or activities are subject to change, postponement or suspension, as decided by the person in charge who will be assigned by Exploramás, who will use the above criteria as well as making a decision on whether participants fulfill the minimum physical and technical requirements to undertake the activity.

3.- Once an activity has begun, any interruption, modification or suspension due to causes beyond the control of the company will not require a refund by Exploramás, nor a substitution for the activity, nor any type of economic compensation. However, if circumstances permit, Exploramás will make an effort to restart or continue the activity during the scheduled period.

4.- If, based on the judgment of Exploramás, the conditions are not appropriate to carry out the scheduled activity or the safety of the participants might be compromised for whatever reason, the activity may be suspended, postponed, or changed before starting. In such a case, Exploramás will clearly and accurately explain the reasons to the customer more than 24 hours before the activity is set to begin and will propose an alternative activity. Once this has been communicated, the customer will have the right to choose between a refund for prior payments (once the costs that Exploramás has undertaken specifically to organize the activity have been subtracted) or the substitution of the scheduled activity with the proposed alternative. If the customer chooses the refund, the customer will be responsible for, in addition to the costs spent by the company up until the time, 25% of the total price to cover costs to set up, plan, and manage the activity. The customer must communicate his/her response within 2 hours of receiving the message from Exploramás. If the response is not sent within this period, it will be understood as acceptance of the alternative activity and the customer will have no right to a refund. If the above-mentioned adverse conditions that prevent carrying out the activity occur while the activity is supposed to begin and, based on the judgment of the Exploramás representatives in charge, compromise the safety of the participants, the activity will be suspended in accordance with the above-mentioned stipulations. If the Exploramás representatives in charge decide that the weather conditions, or any other unplanned for occurrence, does not present a risk to the participants safety, then the activity will be carried out as planned.

5.- The customer promises to accurately inform all participants of the destinations, itineraries, routes to be taken, measures to protect the environment, physical requirements, safety measures, and materials that will be used before beginning the activities. In order to guarantee that all participants are well-informed, Exploramás will provide the customer with all of the above-mentioned information along the price quote by way of the activity specialists.

5.1.- The proposals, descriptions, and images contained in this document are for guidance purposes only. For operational, logistical, safety, or space-related reasons, some challenges, activities, materials, or setups may be modified. In all cases, Exploramás guarantees the essence, quality, and impact of the proposed experience.

6.- Exploramas will be responsible for the work done by its technicians responsible for organizing and coordinating the activities, but in no way will the company be responsible for services provided by third-parties such as those providing lodging, food, etc... that have been contracted and paid directly by the customer.

7.- Exploramas promises to inform the customer about possible risks associated with each activity along with the measures required for accident-prevention and emergency plans. The customer promises to follow all safety measures that the activity specialists require during all activities and to comply with the specialists decisions. If the participants do not comply with these rules, or with the instructions given by the specialists, this may cause, depending on the judgment of the specialists, the cessation or suspension of the planned activities, and it will be considered as if the activities have been fully carried out, exempting Exploramas from any responsibility or obligation to compensate or refund the customer. Activities may also be suspended or postponed if, based on the judgment of the responsible specialist, the footwear or clothing of the participants (not supplied by Exploramas) is not sufficient or appropriate to carry out the activities.

8.- In order for minors, 16 years old or younger, to participate in Exploramas activities, written authorization signed by a the minors parents or guardian must be provided before any activities begin. This clause has no effect on any legally applicable rules and stipulations nor does it exclude minors from the legal norms as they relate to each activity.

9.- Activity prices have been calculated based on fuel prices, tickets, fees and taxes and other applicable concepts at the time that the quote was sent as well as the number of participants as stated by the customer. Any changes with the above-stated items may cause an increase or decrease in the final price for the activity. These changes will be communicated to the customer in a means whereby the commutation can be archived, and the customer will have the option to cancel participation in the activities without suffering any penalties. Under no circumstances will the prices change within 20 of the start date for the activities, unless there is a change in the number of participants.

10.- In cases where an Exploramas activity requires the use of vehicles, Exploramas promises to obtain appropriate vehicles to carry out the activity, but Exploramas will under no circumstances be responsible for breakdowns or other incidents that occur with the vehicles, which will be the responsibility of the company that owns and rents the vehicles.

11.- The customer may cede his place as a participant to another person, as long as that person fulfills all the requirements to carry out the activity, obligating both parties to deposit the costs in case the activity has to be ceased, as well as requiring both parties to respond together for services contracted with Exploramas, specifically in relation to payment. Cessation of an activity must be communicated at least 5 days before the start date for the activity.

12.- During the activities, Exploramas may take photographs and video record the participants, with the exclusive purpose of publicizing and promoting the events organized by Exploramas. Given that the right to one's own image is recognized in article 18 of the Constitution and regulated by Law 1/1982, of May 5, on the right to honor, personal privacy and one's own image and the General Regulations of Data Protection, upon acceptance of the present proposal, unless you indicate otherwise, would be giving us your consent to publish the images in which it appears individually or as a group.
